4. FIRST-AID MEASURES

Inhalation

If inhaled, remove affected person from contaminated area. Keep at rest until recovered. If symptoms develop and/or persist seek medical attention.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Carbon dioxide, dry chemical, foam, water spray or mist.

Under fire conditions this product may emit toxic and/or irritating fumes, smoke and gases including carbon dioxide, carbon monoxide, hydrogen fluoride and oxides of nitrogen.

Specific Hazards Arising From The Chemical

Combustible. This product will burn if exposed to fire.

Decomposition Temperature

> 260 °C

Precautions in connection with Fire

Fire fighters should wear Self-Contained Breathing Apparatus (SCBA) operated in positive pressure mode and full protective clothing to prevent exposure to vapours or fumes. Water spray may be used to cool down heat-exposed containers. Fight fire from safe location. This product should be prevented from entering drains and watercourses.

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Extinguish or remove all sources of ignition and stop leak if safe to do so. Increase ventilation. Evacuate all unprotected personnel. If possible contain the spill. Place inert absorbent, non-combustible material onto spillage. Use clean non-sparking tools to collect the material and place into suitable labelled containers for subsequent recycling or disposal. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of dusts/vapours/mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of dusts/vapours/mists in the work atmosphere. Do not use near ignition sources. Do not pressurise, cut, heat or weld containers as they may contain hazardous residues. Maintain high standards of personal hygiene by washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area away from sources of ignition, oxidising agents, strong acids, foodstuffs, and clothing. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks. Have appropriate fire extinguishers available in and near the storage area. Take precautions against static electricity discharges. Use proper grounding procedures. Ensure that storage conditions comply with applicable local and national regulations.

For information on the design of the storeroom, reference should be made to Australian Standard AS1940 (2017) - The storage and handling of flammable and combustible liquids.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Occupational exposure limit values

No exposure standards have been established for this material. However, the available exposure limits for ingredients/ substances that could be emitted are listed below:

Hydrogen fluoride (as F)

TWA: 3 ppm, 2.6 mg/m³

Note: Peak

TWA (Time Weighted Average): The average airborne concentration of a particular substance when calculated over a normal eight-hour working day, for a five-day week.

Peak Limitation: A ceiling concentration which should not be exceeded over a measurement period which should be as short as possible but not exceeding 15 minutes.

Biological Limit Values

Appropriate Engineering Controls

Provide sufficient ventilation to keep airborne levels below the exposure limits or as low as possible. Where dusts, vapours or mists are generated, particularly in enclosed areas, and natural ventilation is inadequate, a flameproof exhaust ventilation system is required. Refer to relevant regulations for further information concerning ventilation requirements.

Respiratory Protection

If engineering controls are not effective in controlling airborne exposure then an approved respirator with a replaceable dust/mist filter should be used. Refer to relevant regulations for further information concerning respiratory protective requirements.

Reference should be made to Australian Standards AS/NZS 1715 (2009), Selection, Use and Maintenance of Respiratory Protective Devices; and AS/NZS 1716 (2012), Respiratory Protective Devices, in order to make any necessary changes for individual circumstances.

Eye Protection

Safety glasses with side shields or chemical goggles should be worn. Final choice of appropriate eye/face protection will vary according to individual circumstances. Eye protection should conform with Australian/New Zealand Standard AS/NZS 1337 2 & 6 (2012) - Eye Protectors for Industrial Applications.

Hand Protection

Wear gloves of impervious material. Final choice of appropriate gloves will vary according to individual circumstances. i.e. methods of handling or according to risk assessments undertaken. Occupational protective gloves should conform to relevant regulations. Reference should be made to AS/NZS 2161.1 (2016): Occupational protective gloves - Selection, use and maintenance.

Body Protection

Suitable protective workwear, e.g. cotton overalls buttoned at neck and wrist is recommended. Chemical resistant apron is recommended where large quantities are handled.

Carbonyl fluoride is the main decomposition product formed when Poly(ethylene tetrafluoride) is subjected to extended exposure at normal sintering temperatures (400°C). Carbonyl fluoride is immediately converted to highly corrosive hydrogen fluoride in the presence of moist air.
